Research Costs

The LAM Foundation awarded \$200,000 to fund four new research projects in 2025. The
Foundation continued to fund seven active grants which had been approved in prior
years. In September 2025, we hosted an International Research Conference which
featured 97 researchers and clinicians who shared their research and trials to
further advance a cure for LAM.

Patient Services

In September 2025 we hosted a LAMposium which brought 211 patients, family and
friends together in collaboration with our LAM clinic directors, liaisons and
scientists. We offered 41 virtual events, including LAMposium in Your Living Room
webinars, education meetings, and social gatherings. More than 1,000 members of our
global community attended our virtual events, and the recordings continue to be
watched. More than 300 individuals registered with the Foundation. Eleven Circle of
Hope Transplant Support Program participants received lung transplants this year,
resulting in more than 54 tissue samples to further LAM research.

Clinical

The LAM Clinic & Research Network continues to expand and provide locally based,
expert care for women with LAM around the world. We added one clinic in 2025 in
Turkey. The LAM Foundation hosted more than 40 members of the LAM Clinic and
Research Network at the LAM Foundation luncheon at the ATS Conference in San
Francisco, CA.

Each director and principal officer and a member of a committtee with governing board delegated powers annually signs a statement which affirms their understanding and compliance with the conflict policy.
